The various projects will help transform CapMetro's entire bus fleet, on-demand, and paratransit vehicles to zero-emission vehicles. This dynamic leader will take on challenging assignments working with all the internal and external stakeholders to support zero-emission vehicles.

The Director reports to the Vice President, Imagination, Research, and Industry Benchmarking and will work across many of the agency's departments engaging key stakeholders that play critical roles in supporting the integration of zero-emission vehicles and engage partners across the region

The Director, Zero-Emission Vehicle Program will serve as a technical subject matter expert and resource for the agency and enterprise-wide ZEV programs, initiatives, and emerging technologies. This individual will provide extensive, in-depth, and specialized analysis, reporting, operational training, and ongoing procedural improvements related to emerging zero-emission technologies and regulations and will provide the necessary budgetary oversight and administrative accountabilities.

- Bachelor's degree in Engineering, Transportation Planning, or related field. Relevant experience may substitute for degree on a year for year basis up to four years.
- Eight (8) years of experience as a project manager in the transportation industry, including management of consultants and professional staff.
- Extensive and progressively responsible senior management experience in planning, engineering, and transit operational functions, with direct fiscal responsibility.
- Certified Project Management Professional (PMP) by the Project Management Institute preferred.
- Experience in major transportation infrastructure projects.

- Demonstrated knowledge of program administration and evaluation, including goal setting, scheduling, the development of objectives, work planning and organization, budgeting, purchasing, and contractor management; theories, principles and operational practices applicable to ZEV technologies.
