Micro Transit, Major Mobility

How VIA Metropolitan Transit is changing the game with on-demand service - Rm-209

Monday: 10:00-10:55 am (55 Min)

The fastest-growing sector for transit ridership in San Antonio is an on-demand service model VIA Metropolitan Transit launched in 2019, testing zone-based microtransit solutions that offer the convenience of rideshare at bus fare prices. Five years and four zones later, VIA Link service is heading toward 1 million trips as it continues an upward growth trend and 5-star rating from customers.

VIA Link is operated in partnership with RideCo to deliver modern trip options as part of VIA's "Keep SA Moving" plan for comprehensive transit improvements with innovation at the heart. VIA Link service replaced fixed-route buses with accessible vans in the upgrade to a more cost effective and productive operation with an eye toward growth. It was designed to address challenges in low-density areas with limited access to transit hubs, few public transit options, and underperforming bus routes resulting in long waits and travel times.

VIA Link is a transit success story. Since launch, VIA Link zones have produced over 790,000 trips, driven primarily by new customers traveling within the zone. VIA Link is proving right-sized transit solutions create opportunities for growth that complement traditional bus service.

Introducing microtransit service has resulted in significant cost savings for VIA, with operations in its first two zones delivering approximately 75% savings compared to an equivalent 20-minute fixed route service. Significant improvements to the passenger experience come with near-4X frequency compared to fixed routes and walking time reduced from 12 to 5 minutes.

Attendees can learn how a large-footprint transit agency uses on-demand transit to solve mobility challenges in a cost-effective manner. The panel will discuss the impact of on-demand technology as an equitable and innovative solution for communities experiencing first/last-mile gaps. Attendees will learn key elements to successful on-demand deployment through a live example in the industry, including what to consider when planning deployment and the flexible range of service levers that can shape outcomes.

# USDOT Drug & Alcohol Regulation Update (49 CFR Part 40) - Oral Fluid Drug Testing & More! - Room 212-A

On 05/02/2023, USDOT's Office of Drug & Alcohol Policy & Compliance (ODAPC) published a final rule in the federal register, officially updating and changing 49 CFR Part 40, which is the official regulation for the USDOT's drug and alcohol testing program. The changes became effective June 1, 2023. Among other changes, this updated final rule amends the USDOT's regulated industry drug testing program to include oral fluid drug testing as an alternative to urine specimen drug testing. This additional methodology for drug testing will give employers a choice that will help combat employee cheating on urine drug tests and provide a less intrusive means of achieving the safety goals of the program.

#### Building a Safety Culture with Countermeasures that Work-Room 209

Millions of workers drive or ride in a vehicle as part of their jobs, and motor vehicle crashes are the leading cause of work-related deaths in the United States. All workers are at risk of crashes, whether they drive light or heavy vehicles or whether driving is a main or incidental job duty. Motor vehicle crashes are the 1st or 2nd leading cause of death in every major industry group. In 2021, 1,982 U.S.

workers driving or riding in a motor vehicle on a public road died in a work-related crash (38.2% of all work-related deaths). With driving being fundamentally one of the most dangerous tasks we do, building a culture of safety is non-negotiable.

## Active Shooter Awareness and Preparedness - Room 209

Tuesday: 2:40 pm -3:40 pm (60 min)

Hear the behind the scenes stories of many of the most recent mass shootings, how they happened, how they were planned, how law enforcement responded, and important clues that could potentially prevent future such tragedies. The presenter has responded to two school shootings and the shooting of Congresswoman Gabriel Giffords. John was also present in Las Vegas when the Mandalay Bay shooting occurred, where he then served as an on-air Law Enforcement consultant for the Fox News Channel, CNN NBC, and other national news programs, giving him inside access to the crime scene. This access, in addition his having responded to numerous other critical incidents as an FBI Agent and police officer, gives John unique knowledge insights that he shares with his audience.

#### Bus Operator's Retention, Run Preferences, and Run-Life Conflicts-Room 210-A

This session will address the ongoing shortage of operators—especially the challenge of retaining bus operators. The session will be based on TTI's "Bus Operator Retention Analysis" study conducted for Capital Metro in Austin, TX. The session will offer attendees:

- · A review of the challenge of bus operator retention and current trends.
- · Potential elements influencing operators' decisions to stay with a transit agency.
- $\cdot$  Factors contributing to the turnover of bus operators.
- · Practical solutions aimed at reducing turnover.

The information presented will be based on data collected in 2023 from bus operator focus groups, interviews, and a survey with 160 respondents. Participants will have the opportunity to learn about the operators' preferred runs/shifts, desired weekdays/weekends for off and run, and preferences towards split and straight shifts. Attendees will depart with an enhanced understanding of how to "get to the bottom of" issues causing turnover among bus operators and potential strategies, initiatives, and policies that can enhance the retention of bus operators.

# We All Play a Role: Equity in Transit, from the Practitioner's Perspective - Room 211

Have you ever wanted to hear from your colleagues and peers about how they approach equity considerations in their agency? Do you have interesting insights about how transit can be more/most equitable? This session is designed to give you the chance to learn from other practitioners and to share your insights. Following the format of an unconference (and after a brief foundational presentation led by the facilitator), this session will offer an opportunity for all attendees to propose equity-oriented discussion topics (e.g., measuring equity, fare-free transit, serving people experiencing homelessness) and/or vote on those that most interest them. Following the facilitated voting exercise, participants will join small group discussions focused on the top 2-5 topics (depending on interest and number of attendees) and select a group scribe to record notes from the discussion. At the end of 45 minutes of discussion, each group will report

out to the rest of the attendees with the goal of sharing 3 main takeaways and identifying another set of discussion topics for voting. The voting and group discussion process will occur a total of 2 times in a 90-minute session. The facilitator will prepare a voting system (e.g., Poll Everywhere or Google forms) to facilitate collection of ideas and note taking forms (via Google Doc) for each discussion group's scribes. All notes will be made available to all session participants via a public link.

#### Fleet Configurations for Paratransit and Other Demand Responsive Transportation Services - Room 209

Tuesday: 3:50 pm -4:50 pm (60 min)

More This session will cover the findings from TCRP Synthesis SB-38, Paratransit Fleet Configurations, which is in the final stages of being published as Synthesis 174. Through a national survey and case studies, the synthesis explores the propensity among differently sized transit agencies to maintain a uniform fleet of wheelchair-accessible vehicles (WAVs) vs. a mixed fleet of different types and sizes of WAVs vs. a mixed fleet of WAVs and non-accessible vehicles for their paratransit service.

Factors impacting these planning and purchasing decisions included purchasing and operating costs, delivery time of different types of vehicles, CDL requirements (given the industry issues with driver recruitment and retention), nimbleness in reaching certain pickup and drop-off locations and navigating steep grades, and capacity vs. demand. The presentation will cover the results of the survey and the successes, obstacles, and lessons learned from the case studies.

Through audience participation, the session will also explore the extent to which these factors and lessons learned also apply to other demand-responsive transportation services such as rural dial-a-ride and microtransit services where transit agencies provide the fleet.
